- (iii). A bond has face value of Rs. 1000 with time to maturity eight years from now. The rate of return of the bond now is 10%.
- (a) What is the price of this bond today, if it pays no coupons?

- (b) Calculate the intrinsic value of this bond if it pays annual coupons of 10%.  
(01 mark)
- (c) Compute the price of a bond today if it pays 6% coupon rate annually.

(iv) Union Star corporations' Rs. 1000 value of bond pay interest on January 15 and July 15 and they will mature on July 15, 2022. Their coupon rate is 10%. Because of the risk characteristics of bond, you require a return of 12% annually on this bond.

(b) How much should you pay for a Rs. 1000 bond on July 16, 2018? (04 marks)

(iii). What are the two elements in the expected returns of a constant growth stocks? Explain briefly your answer using the equation for expected rate of return for common stocks. (03 marks)

(iv). Consider the valuation of a common stocks of Hilllake corporation that has a current dividend of Rs. 1.80 per share. Dividends are expected to grow at a rate of 15% for the next five years. Following that, the dividends are expected to grow at a rate of 10% for five years. After ten years the dividends are expected to decrease each year at a rate of 5% per year, forever. Stockholder's required rate of return is 10%.
