- 2. A 7- year old boy was brought to Child Psychiatry clinic by his mother because his class teacher wanted this child seen by a doctor. Mother was told by the teacher that the child does not stay seated in the class, often walks around the class and does not complete work. Mother reveals that when at home child quarrels with younger sister often and shows risky behaviors.
- 2.1. Mention three direct questions you would ask the mother with the view of arriving at a diagnosis. (30 marks)

She says she was raped by a known person five months back and has little memory of the event. She did not seek medical care at that time. The patient said she had not told anybody about the incident and continued to attend work. However, she said she felt sad and anxious about what had happened, and has been having difficulty in sleeping due to frightening nightmares. 3.1. What is the most likely diagnosis? (20 marks) 3.2. Write two more questions you would ask in the history to confirm the diagnosis? (30 marks) 3.3. Write two relevant aspects (other than the psychiatric condition) you may need to address in her. A 35 year- old clerk who has been attending the psychiatry clinic for past 10 years said that he was given several different medications over the years which he has taken regularly. He claimed that he is still hearing voices commenting on his actions and is being controlled by the internet. 4.1. What is the most probable diagnosis? (20 marks) 4.2. (10 marks) 5.2. Write difference between attempted suicide and deliberate self-harm. (10 marks) 5.3. A 23- year old unemployed girl was admitted to a medical ward following ingestion of one packet of 'Prinso' (a detergent). It was revealed that she ingested it after her parents advised her to stop her love affair. 5.3.1 Write two questions the doctor could ask to assess her knowledge of the lethality of 'Prinso'. (20 marks) 5.3.2. Write two questions which will help the doctor to determine whether her act was impulsive. (30 marks)
